FUND MANAGER COMMENTARY

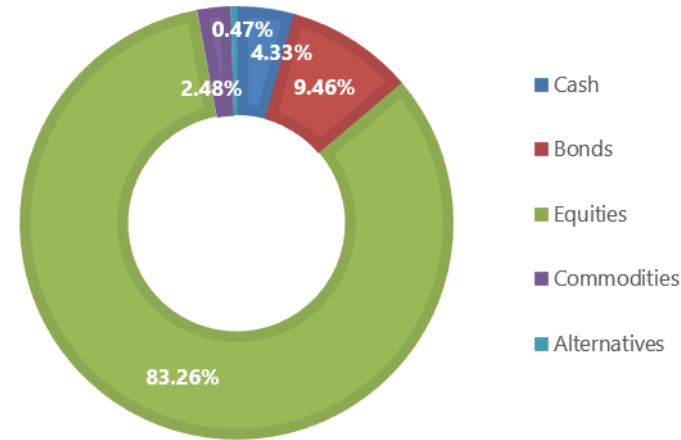
MARKET REVIEW

June’s preliminary US-Iran peace agreement proved the defining market event, triggering a sharp unwinding of geopolitical trades as oil fell, gold shed its safe-haven premium and energy positions were swiftly liquidated. The Strait of Hormuz remains far from resolved, however, and any comfort around supply should be treated as time limited. In sterling terms, European equities led the month with the EURO STOXX rising 3.21%, while China was the notable laggard, falling 5.64% as investors reassessed its growth outlook. Stepping back, 2026 tells a more remarkable story: Asia Pacific has returned 27.89% year to date as the AI-driven semiconductor cycle powered Korean and Taiwanese markets to record highs, and the S&P 500 has delivered 11.49% against a backdrop of war, energy shocks and political uncertainty. Looking ahead, AI, energy security and rising defence budgets continue to create opportunity for active investors, though markets are growing more selective; we are positioned constructively for a return to full global momentum by 2027, while retaining a deliberate allocation to more defensive assets should events prove less orderly than we expect.

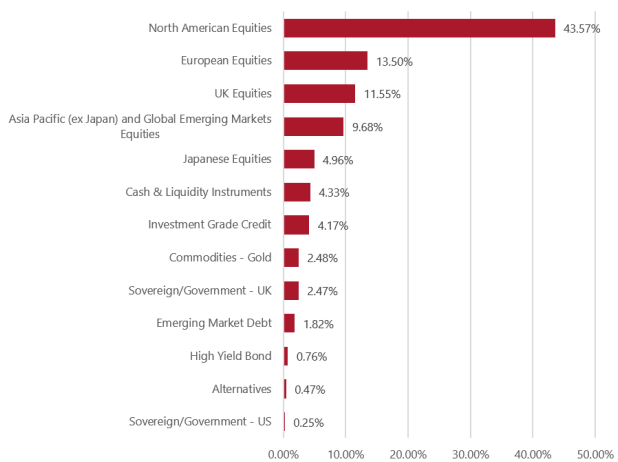
FUND REVIEW

The Growth Fund outperformed its benchmark during June, extending its year-to-date lead to 10.44% against the benchmark’s 8.33%. Our diversified US equity exposure was the primary driver of returns, with dedicated allocations to large-cap value and small- and mid-cap companies delivering strongly at a time when growth stocks lagged. Investor scepticism around the returns on hyperscaler AI spending weighed on the largest technology platforms during June, even as select semiconductor names continued to perform well. Our deliberate diversification within the US allocation continues to prove its worth.
