

PORTFOLIO OBJECTIVE AND SUITABILITY

The investment objective of the portfolio is to preserve capital and generate capital growth (the increase in value of investments) over the long term by investing in the MW Cautious Multi Asset Fund, which is a fund of funds structure and invests in a diversified portfolio of funds. The portfolio is suitable for investors willing to invest for the long term while accepting some short-term price volatility to generate sustained longer-term capital growth and income.

INVESTMENT STRATEGY

The investment strategy of the portfolio is to invest in the MW Cautious Multi Asset Fund, which invests in a range of funds in order to benefit from asset class diversification. The portfolio will invest in equity markets to benefit from the higher return potential while using fixed income to provide diversification, stability and income.

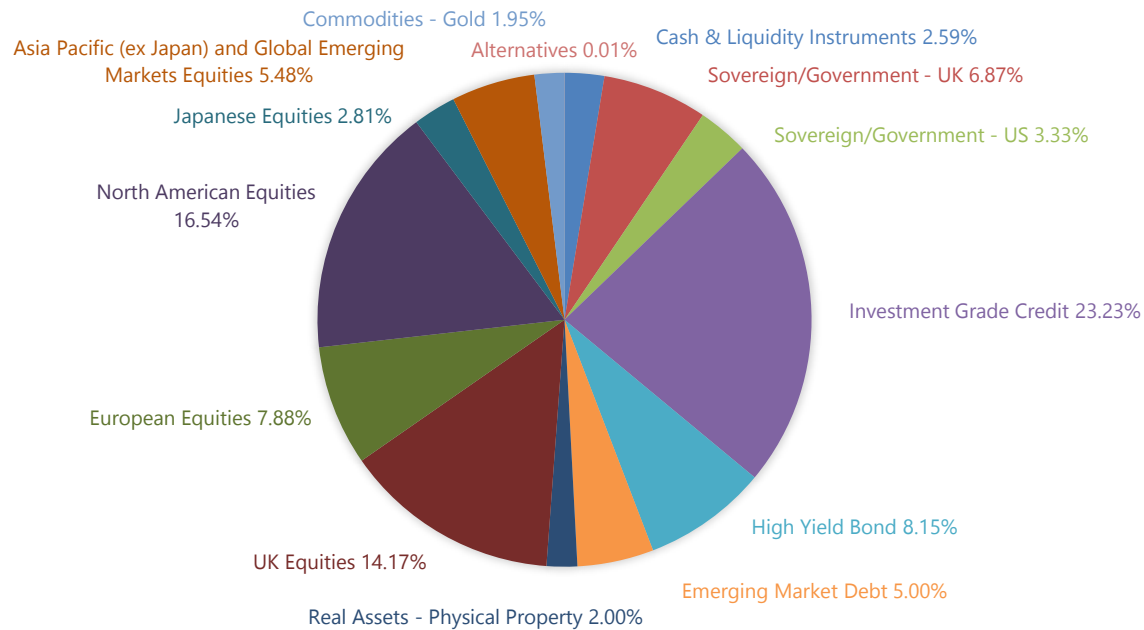
