

### PORTFOLIO OBJECTIVE AND SUITABILITY

The investment objective of the portfolio aims to achieve capital growth (the increase in value of investments) over the long term by investing in the MW Growth Multi Asset Fund, which is a fund of funds structure and invests in a diversified portfolio of funds. The aim of the portfolio is to generate returns more stable than investing solely in equity markets. The high equity weighting in this portfolio means it is likely to experience more price volatility than a more defensively positioned portfolio and should be invested in for the long term.

### INVESTMENT STRATEGY

The investment strategy of the portfolio is to invest in the MW Growth Multi Asset Fund, which invests in a range of funds in order to benefit from asset class diversification. The portfolio will invest in equity markets to benefit from the higher return potential while using fixed income to provide diversification, stability and income.

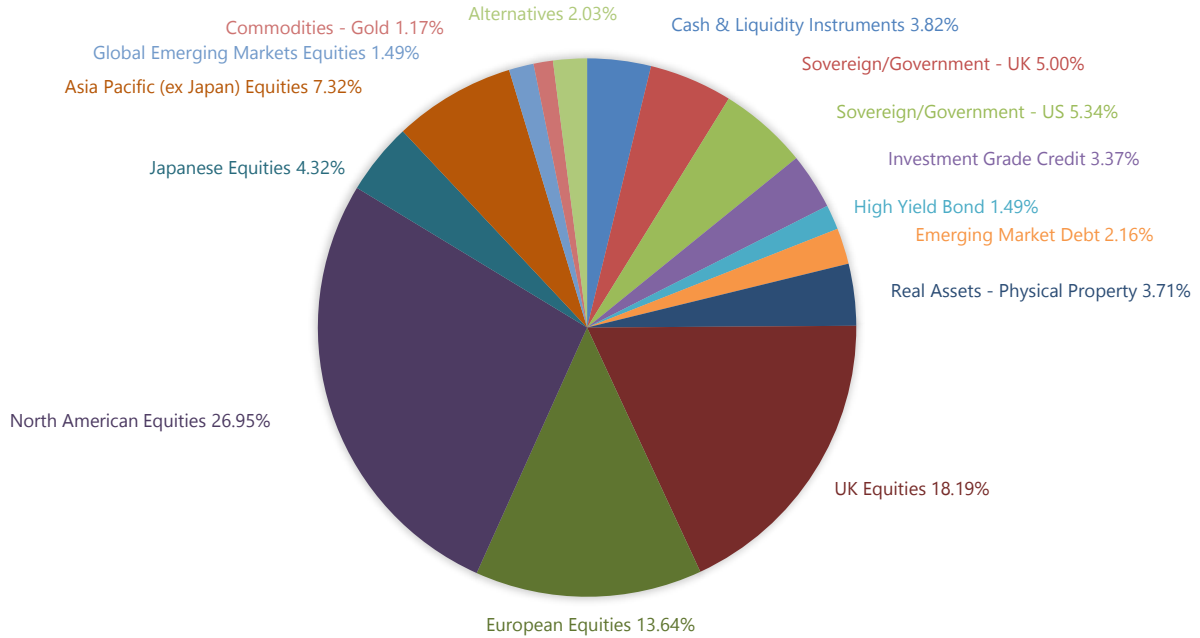
